The Term shall automatically renew for a term that is equal to the initial term at the end of each then current term at Quickride's then-current rates unless Customer provides written notice of termination to Quickride within Thirty (30) days of the end of the then current term. Both parties acknowledge that this is not a technology license agreement and, except as provided for in this Agreement it does not give Customer any right to use any proprietary software and hardware technology used by Quickride to provide the Services. Customer has read and agrees to be bound by the Terms and Conditions and Additional Service Terms and Conditions, each of which are incorporated herein by reference and are subject to updating by Quickride in its discretion, and shall become effective 30 days after posting to the website. Quickride and/or its technical partner are required to access your DMS to provide Services. Quickride will use commercially reasonable efforts to keep the data secure. Quickride will not be responsible for any misuse or unauthorized disclosure or release of usernames, passwords, and /or data obtained by the Quickride or its Partner hereunder.
